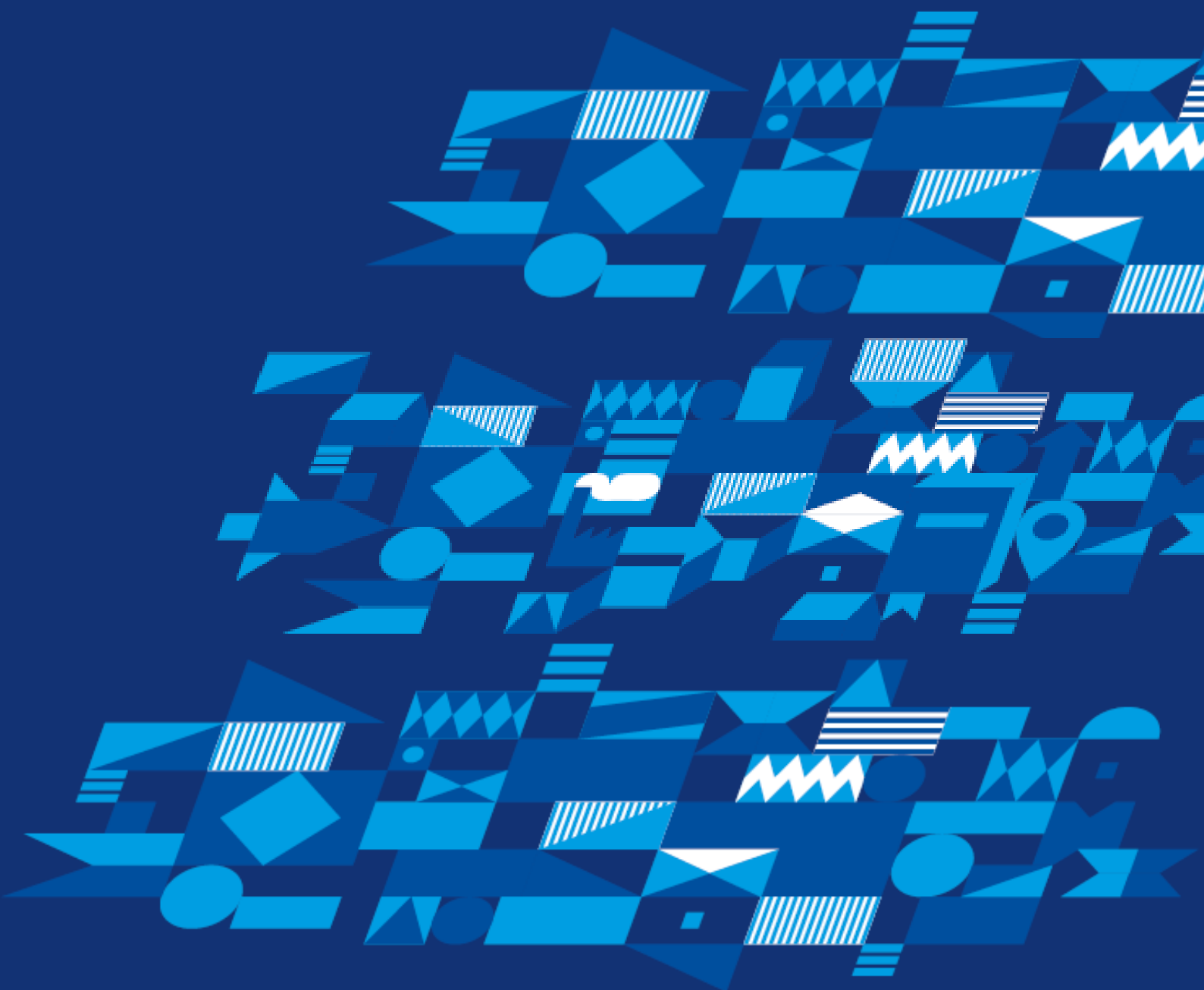

**NOTE to 1.6.:**

1. The fee shall be charged only if payment documents in RMB / a foreign currency need editing / adjusting (additionally to the fee specified in 1.5. hereof) which haven't passed automatic processing as to meeting the requirements of VTB Bank (PJSC) to formatting messages as format of SWIFT or other formats of useable communication systems.
